Private Patio Information, Contract and Deposit

Capacity:

Our private patio seats 35 people.

Seating on our private patio is only guaranteed if there is a signed contract.

Minimum: Please note that 7% tax and 20% gratuity do not apply towards the minimum

- Lunch- Monday-Thursday \$450 food and beverage minimum
- Lunch- Friday - Sunday \$650 food and beverage minimum
- Dinner- Monday-Thursday \$550 food and beverage minimum
- Dinner- Friday - Sunday \$950 food and beverage minimum

*We are unable to book the private patio on Friday and Saturday between the hours of 6pm-8pm. Friday and Saturday dinner Seating's are available from 4pm-6pm or 8pm-10pm.

*All parties are booked and reserved for two hours. **Additional hours can be added for an increased minimum of \$125 an hour.** The increased minimum can be used towards the total food and beverage requirement. The minimum does not include gratuity or sales tax.

Gratuity:

All food and beverage totals will be subject to a 20% gratuity.

Payment:

One form of payment will be accepted for all private patio contracts.

Cancellation Policy:

A \$100.00 credit card deposit is required to hold the room. The card will not be charged unless there is a cancellation issue. Cancellation within 48 hours of the event will result in the loss of the \$100.00 credit card deposit. No-shows or cancellations the day of the event will result in full payment of the required food and beverage minimum.

Decorations:

We welcome you to decorate the room! Please take all decorations with you when leave. We ask that you do not use glitter or confetti. Please do not hang, tape, or affix anything to the walls, chairs, tabletops, fixtures, ceiling, or doors. All decoration time is included in the 2-hour reservation window.
